

Parties

This variation agreement is entered into between:

- **nbn co limited (ABN 86 136 533 741)** of Level 13, 100 Mount Street, North Sydney NSW 2060 **(nbn)**; and

Background

nbn and RSP have entered into a Wholesale Broadband Agreement (version 5) which has been subject to subsequent amendments in accordance with its terms (**RSP's WBA**). The amendments in this variation agreement vary the RSP's WBA to introduce:

- (a) **nbn**® Smart Places as a new Product Module; and
- (b) **nbn**® Smart Places into the Sandpit Module.

In addition, the amendments introduce new provisions to support the above construct (together, the **Smart Places Amendments**).

The Smart Places Amendments are marked up against the Wholesale Broadband Agreement Standard Form Access Agreement as at the date on which this variation agreement is first offered by **nbn** to RSP or any Other RSP (**SFAA**).

While the Smart Places Amendments will be effective on the later of the date RSP agrees to this variation agreement and the Commercial Launch Date, **nbn** may at a later date introduce further amendments relating to the SFAA via the change mechanism in F4 of the Head Terms to the RSP's WBA (**Future Amendments**). RSP agrees that, to the extent any Future Amendments differ or are additional to the Smart Places Amendments, the RSP's WBA will be amended to include the Future Amendments.

Amendments

nbn and RSP agree that, upon the later of the date that the parties agree this variation agreement and Commercial Launch Date (**Effective Variation Date**):

(a) the RSP's WBA is amended such that each document listed below is inserted or replaces the corresponding version of that document in the RSP's WBA in its entirety, (as indicated by version 5.0 or 5.x respectively):

If **nbn** introduces Future Amendments, upon receiving written notice from **nbn**, the RSP's WBA (as varied from time to time) will be amended to include the Future Amendments, to the extent those amendments differ or are additional to the Smart Places Amendments.

General terms

Unless otherwise specified, capitalised terms used in this variation agreement have the meanings given to those terms in the RSP's WBA.

Clauses H4.5 (Electronic execution and counterparts) and H4.10 (Governing law and jurisdiction) of the Head Terms of the RSP's WBA apply to this variation agreement.
