## Introduction

This document applies to the CSAS Interim Terms.

This document sets out the Charges and other amounts payable in connection with NBN Co's supply of the CSAS.

Charges in this CSAS Price List are separated into recurring Charges and other Charges. Recurring Charges are periodic amounts which are payable in each Billing Period that a product or service is supplied by NBN Co to Customer. Other Charges are non-recurring and are payable only when certain activities or events occur (e.g. installations, disconnections).

Details of the CSAS Service Fault Rectification Rebate are set out in the CSAS Service Levels Schedule.

Section 1 sets out the recurring Charges which apply to the CSAS Product Components which Customer must acquire as part of the CSAS. The specific Charges which apply to an Ordered Product depend on the Product Features selected by Customer (e.g. bandwidth profile).

## 1. Recurring Charges for core components

### 1.1 AVC and UNI

- (a) The recurring Charges for the AVC TC-1, AVC TC-2 and UNI bundle depend on the classification (whether Metro, Outer Metro or Regional) of the POI serving the CSAS Point.
- (b) The recurring Charges per Billing Period for the AVC TC-1, AVC TC-2 and UNI bundle are:

  - (ii) one AVC TC-2 as per the table at section 1.1(b); and
  - (iii) one UNI-D in connection with the supply of the AVC to a CSAS Point.

The recurring Charges per Billing Period for the NNI Bearer Product Component are:
